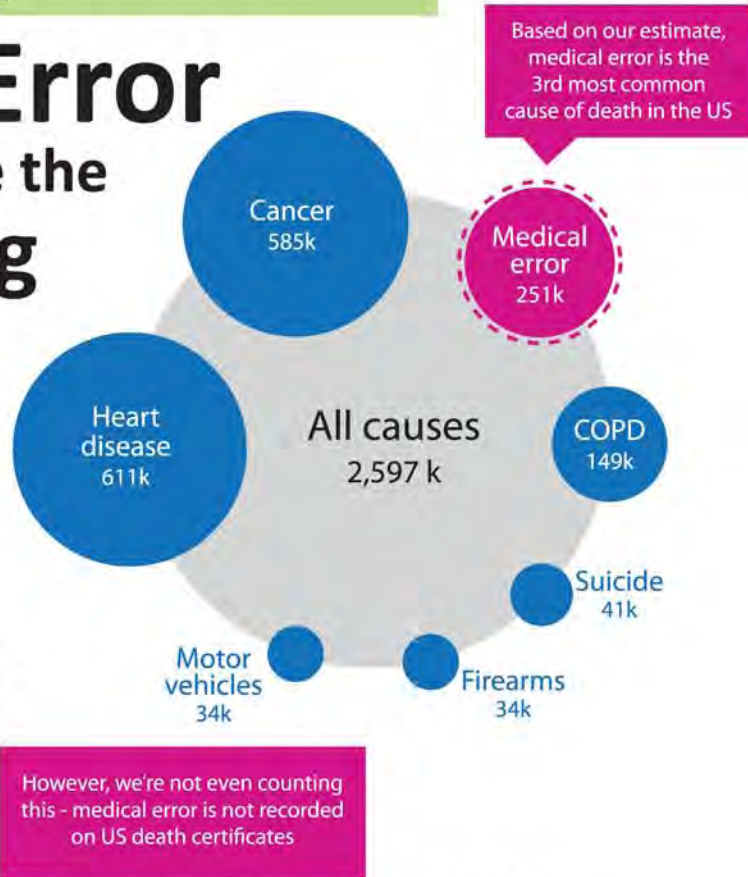


Fig 1 Most common causes of death in the United States, 2013²

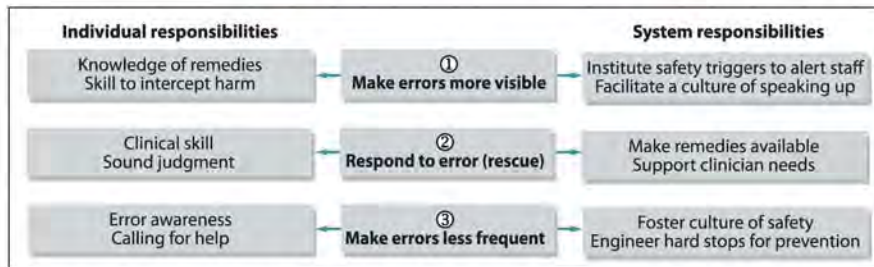


Fig 2 Model for reducing patient harm from individual and system errors in healthcare

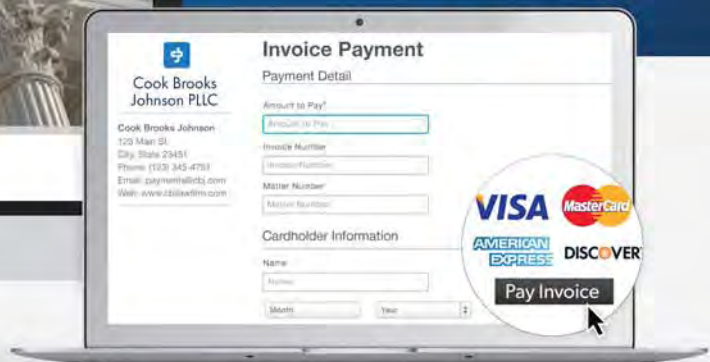
