Water is a business! City Council and rural water district boards have a lot to consider: water pressure, meeting all federal and state regulations and standards, and making rates affordable. In fact, their job is making the right choices about complex managerial, financial, and technical aspects of running a high quality water utility. **KanCap training will discuss water system capacity. Each training session will begin with refreshments and sign-in at 8:30 a.m. Class will begin at 9:00 a.m. and adjourn at 4:30 p.m. Lunch will be provided.**

**WATER SYSTEM CAPACITY** is the ability to plan for, achieve, and maintain compliance with applicable drinking water standards. Capacity consists of three elements: Technical, Financial, and Managerial (TFM).

**Technical Capacity:** The physical and operational ability of a water system to meet Safe Drinking Water Act requirements, including the adequacy of physical infrastructure, technical knowledge and capability of personnel, and adequate source water.

**Financial Capacity:** The ability of a water system to acquire and manage sufficient financial resources to allow the system to achieve and maintain compliance with SDWA requirements.

**Managerial Capacity:** The ability of a water system to conduct its affairs in a manner enabling the system to achieve and maintain compliance with SDWA requirements, including institutional and administrative capabilities.
