

## Consent to Publish Form

The undersigned author (the "Author") is the writer of an original work described below in this Agreement (the "Work") to be published by the Maryland Pharmacists Association (the "Association"). Based on valuable consideration, for which the Author acknowledges receipt, the Author assigns, grants, and licenses to the Association all right, title and interest, including copyright and including all modes or mean, in and to the Work; the Author retains no ownership rights whatsoever in the Work except specifically described in this Agreement. The Author authorizes the Association to edit or rename the Work at the Association's exclusive discretion, and to publish the Author's name, photograph, and biographical information in connection with the Association's use and promotion of the work if the Association chooses, in its sole discretion, to do so. It is understood and accepted that the Author will receive no royalty or other compensation from the Association for this assignment, grant, and license of the copyright for the Work to the Association,

1. The Association assigns, grants and licenses back to the Author a limited right (1) present the Work orally; (2) distribute the Work for educational, personal or other noncommercial uses or for the Author's own professional use; and (3) revise, adapt, or prepare derivative works and to present such works orally as well as distribute or authorize publication of the works for educational, personal, or other noncommercial uses or for the Author's own professional use;

Provided in all instances, however, that (a) these uses of the Work may not reasonably be considered similar to the use or publication of the Work by the Association or in any respect in competition with the Association's uses of the Work, in which case the prior approval of the Association must be obtained; (b) that an appropriate written acknowledgement is included in the Author's use or publication of the Work that it is undertaken with the permission of the Association; and (c) that the Association has the right of first refusal to use or publish any revised, adapted, or derivative works.

2. The Author represents and warrants that to the Association that the Work was created by the Author alone and that the Author has the exclusive right to make this assignment, grant, and license, that the Work is factually accurate and lawful, that the Work does not violate any copyright, contract, proprietary, privacy or personal rights of others, and that the Authors knows of no present or potential claim or demand for ownership or other rights to the Work.
3. The Author indemnifies and holds harmless the Association and its officers, directors, employees, and agents from and against any claim, lawsuit, or liability arising in any way in connection with the Author's assignment, grant, and license to the Work.
4. The Agreement is the only one between the Association and the Author on this subject; it may be amended only by a written document signed on behalf of both the Association and the Author; any disputes regarding this Agreement are to be resolved according the laws of the State of Maryland.
