With the Credit Union Political Action Committee's (CUPAC's) Automatic Political Recurring (APR) contribution program, you can help ensure the vitality of the credit union movement by supporting credit union-friendly political candidates running for state office.

Why contribute to political candidates?

Every year Minnesota's elected officials consider and pass countless pieces of legislation that directly and indirectly affect your credit union's operations and its ability to serve members. Consequently, it is imperative that credit union friendly-candidates are elected to advocate on behalf of the state's credit unions. By participating in CUVOL's APR contribution program, you support local candidates like state senators, representatives and the governor. In this way, you provide financial assistance to individuals who care as much about the credit union movement as you do.

How does the APR contribution program work?

APR makes contributing to credit union supporters more convenient. Choose a dollar amount to contribute, and each month it will automatically be charged to your credit card. Strengthening the movement has never been easier!

CUPAC is the state political action committee of the Minnesota Credit Union Network (MnCUN). Donations to CUPAC are used to support credit union-friendly candidates who are running for state office. CUPAC can only accept personal contributions, not corporate contributions. Contributions to CUPAC are not tax-deductible for state or federal income tax purposes. Contributions are strictly voluntary, and you have the right to refuse to contribute without reprisal. State election law requires MnCUN to report the name, address, date and amount of contribution and name of employer for individuals who contribute more than \$20 in a calendar year.
